TOWN OF NEWELL COMMISSIONER MEETING MAY 9th, 2022 UNAPPROVED MINUTES

The Town of Newell Commissioners met in regular session at 18:00 at the Town Office Building. The meeting was called to order by Mayor Wetz followed by the Pledge of Allegiance. Mayor Wetz, Commissioner Adams, Commissioner Olson, Commissioner Tennis, Commissioner Youngberg, Finance Officer Smith and Finance Clerk Wetz were in attendance.

Adopt the Agenda: Motion made by Commissioner Adams to approve the Agenda for May 9th, 2022, 2nd by Commissioner Olson. All in favor, motion carried.

Approve Minutes: Motion made by Commissioner Tennis to approve the minutes from the Regular Commissioner's Meeting April 11th, 2022, 2nd by Commissioner Olson. All in favor, motion carried. **Commissioners Oath of Office:** Finance Officer administered the Oath of Office to Commissioner Youngberg and Commissioner Adams.

Public Hearing on Wastewater System Improvement Project: Mayor Wetz opened the Public Hearing for the Wastewater System Improvement Project. An explanation of the project was given by Jason Hanson and Chancey Shrake from Brosz. Engineering and Bill Lass, Black Hills Council of Governments. Brosz Engineering explained how the project would benefit the city. Bill Lass explained the total amount in loans requested to complete the project is estimated to be \$603,000 with a 2.125% interest rate for 30 years. Mayor Wetz called for public comments/concerns. The need for the project for future growth and rising water rates were discussed. Mayor Wetz closed the Public Hearing.

Public Hearing on Water System Improvement Project: Mayor Wetz opened the Public Hearing for the Water System Improvement Project. An explanation of the project was given by Chancey Shrake and Jason Hanson from Brosz Engineering along with Bill Lass from Black Hills Council of Governments. Brosz Engineering explained why the project is needed for the City of Newell. Bill Lass explained the financial aspects of the Project. The total of the loan requested for the project is estimated to be \$992,000 with an interest rate of 1.625% for 30 years. Mayor Wetz called for public concerns/comments. None were heard. Mayor Wetz commented that if the town is going to be able to accommodate any future growth the city needs to update the aging system. Mayor Wetz closed the public Hearing.
