Renting of the City Hall Building: Discussion was heard about renting the city hall for different types of events after the floor being restored. Mayor and Commissioners thought the floor held up very well for years that they did not see any concerns at this time and would address any if would come up.

Boring under Ash Street: Discussion was heard about boring that needed to be done under Ash Street and the

need of WRCTC needing a place to store their equipment while on job site. As discussion was heard it was clear that the boring may not be needed any longer on Ash Street so Foreman Parker received the go head from the Commissioners to make a deal with WRCTC if needed boring elsewhere other than Ash Street.

Fishing Extension: Mayor stated that when we put the dock in the lake last fall as the lake lost water the dock would go up in the air. So he talked with Game Fish and Wildlife about an extension. Game Fish and Wildlife came back to him with a 2 section for \$6,600. Mayor Keolker said we only needed half that one so they are checking on a 16 feet for matching funds. The Mayor only needs to know if the Commissioner would like them to go on with the processes. All Commissioners are on board with the processes and to continue on. Mayor Keolker will do so.
